SECTION 29, TOWNSHIP 3 SOUTH, RANGE 16 EAST COLUMBIA COUNTY, FLORIDA

DESCRIPTION:

BEGIN at the Southeast corner of the Northwest 4, Section 29, Township 3 South, Range 16 East, Columbia County, Florida and run 5.89°56'55" W. along the South line of said Northwest 4 a distance of 200.00 feet; thence N. 0°44'09" E. 1342.08 feet to the North line of the Southeast 1/4 of the Northwest 1/4, Section 29; thence 5. 89° 44 58" E. along said North line 700.00 feet to the Southwest corner of the Northwest 1/4 of the Northeast 1/4; thence N. 0° 44' 09 E along the West line of soid Northwest 1/4 of the Northcast 4 a distance of G35.57 feet; thence 5.89°35"51"E 1004.09 feet; thence 5.0°30'07"W. G32.84 feet to the North line of the Southwest 4 of the Northcast 4, Section 79; thence 5.89°44 58"E along said North line 355.57 feet to the Northcast corner of said Southwest 4 of the Northeast 4, Section 29; thence 5.0°30'02" W. along the East line of said Southwest 4 of the Northeast 4 a distance of 1333.80 feet to the Southwest corner of said Southwest 4 of the Northeast 4, Section 29; thence 5.89°56'55" W. along the South line of said Southwest 4 of the Northeast 4 a distance of 1367.83 feet to the POINT OF BEGINNING.

- 2. 4x4" concrete monument with bross cap in top stamped L.L.Loc & Assoc Inc. with surveyors registration number and date. 3. O Permanent Control Point (PC.P.) ~ 1/2" Iron with cap stamped with P.C.P. number and surveyors registration number. 4. Boundary and bearings based on prior work in this area by L.L.
