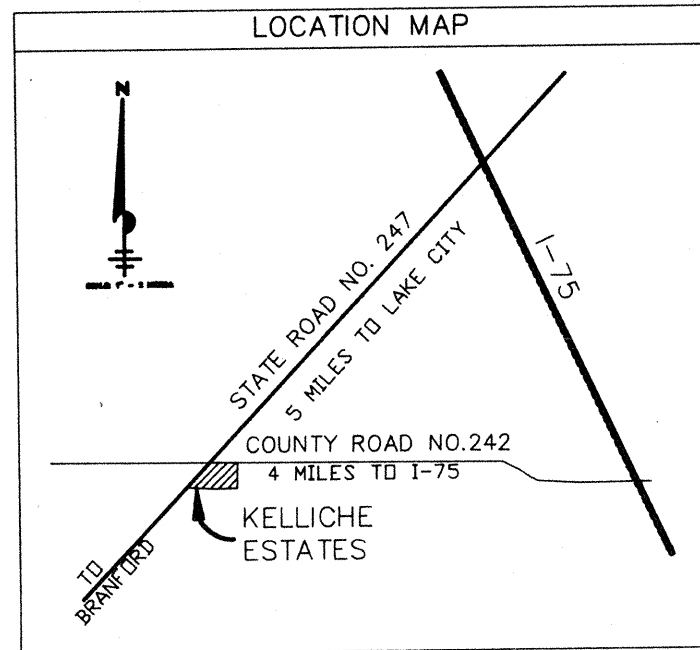


# KELliche ESTATES

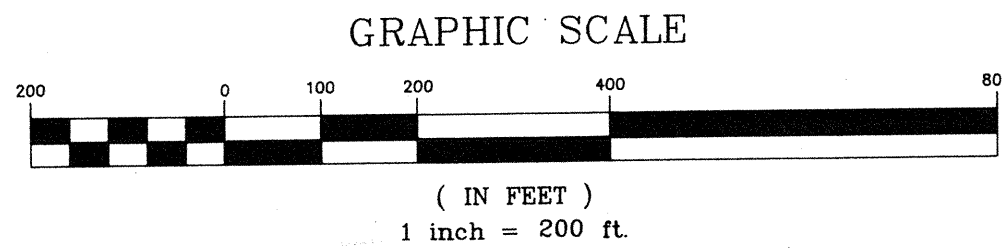
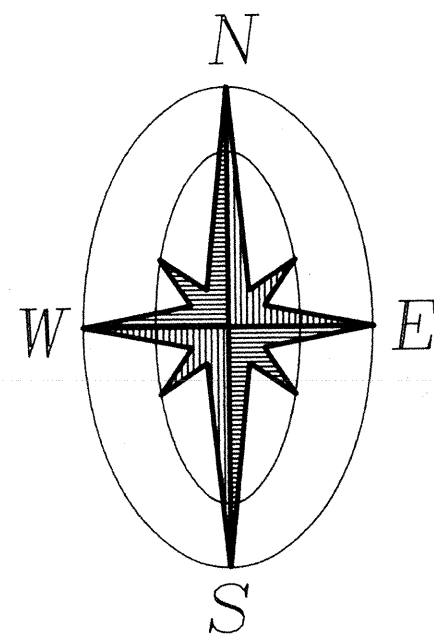
COMMENCE AT THE NORTHEAST CORNER OF SAID SECTION 29 AND RUN THENCE SOUTH 00°24'23" WEST, ALONG THE EAST BOUNDARY OF SAID SECTION 29 76.28 FEET TO THE SOUTH RIGHT-OF-WAY LINE OF COUNTY ROAD NO. 242 (80' R/W); THENCE SOUTH 89°03'25" WEST, ALONG SAID SOUTH RIGHT-OF-WAY LINE 150.04 FEET TO THE POINT OF BEGINNING; THENCE SOUTH 00°24'23" WEST, PARALLEL WITH SAID EAST BOUNDARY 1090.13 FEET; THENCE SOUTH 65°24'23" WEST, 544.49 FEET; THENCE SOUTH 73°24'23" WEST, 830.00 FEET; THENCE NORTH 87°26'05" WEST, 673.75 FEET TO THE SOUTH-EASTERLY RIGHT-OF-WAY LINE OF STATE ROAD NO. 247 (100' R/W); THENCE NORTH 41°30'58" EAST, ALONG SAID SOUTHWESTERLY RIGHT-OF-WAY LINE 1782.39 FEET; THENCE SOUTH 48°29'02" EAST, 600.00 FEET; THENCE NORTH 89°03'25" EAST, 43.46 FEET; THENCE NORTH 00°56'35" WEST, 581.00 FEET TO SAID SOUTH RIGHT-OF-WAY LINE OF COUNTY ROAD NO. 242; THENCE NORTH 89°03'25" EAST, ALONG SAID SOUTH RIGHT-OF-WAY LINE 306.81 FEET TO THE POINT OF BEGINNING.

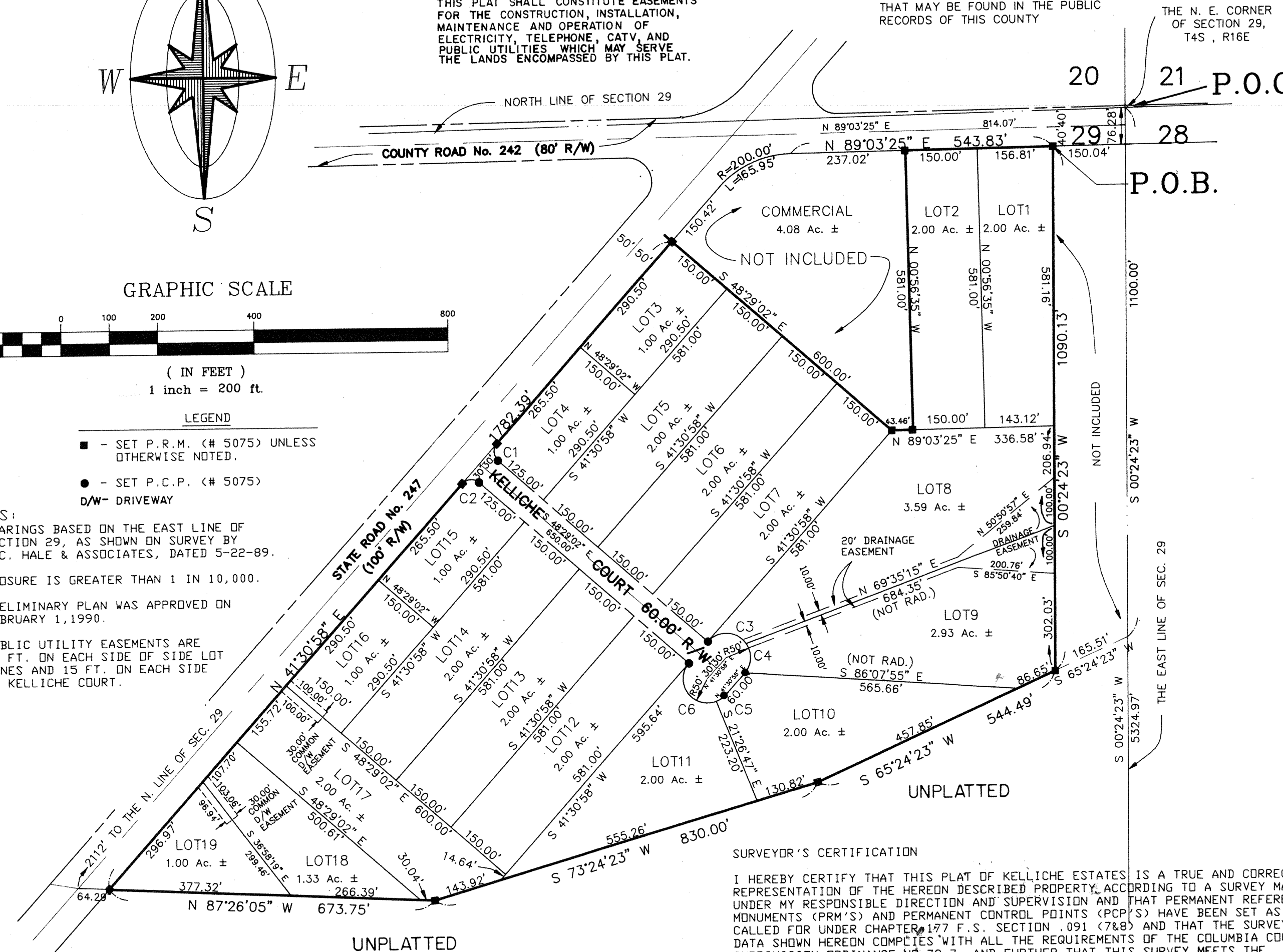
