BEGIN AT THE NORTHWEST CORNER OF SECTION 5, TOWNSHIP 4-SOUTH, RANGE 17-EAST, COLUMBIA COUNTY, FLORIDA AND RUN N. 88° 05' E, ALONG THE NORTH LINE OF SAID SECTION 5, 525.0 FEET, THENCE S. 1° 44' WEST 542.0 FEET, THENCE S. 10° 08' W. 58.2 FEET, THENCE S. 87° 37' W. 785.3 FEET TO THE WEST LINE OF SAID SECTION 5, THENCE N. 1° 16' W. 500.0 FEET TO POINT OF BEGINNING.
