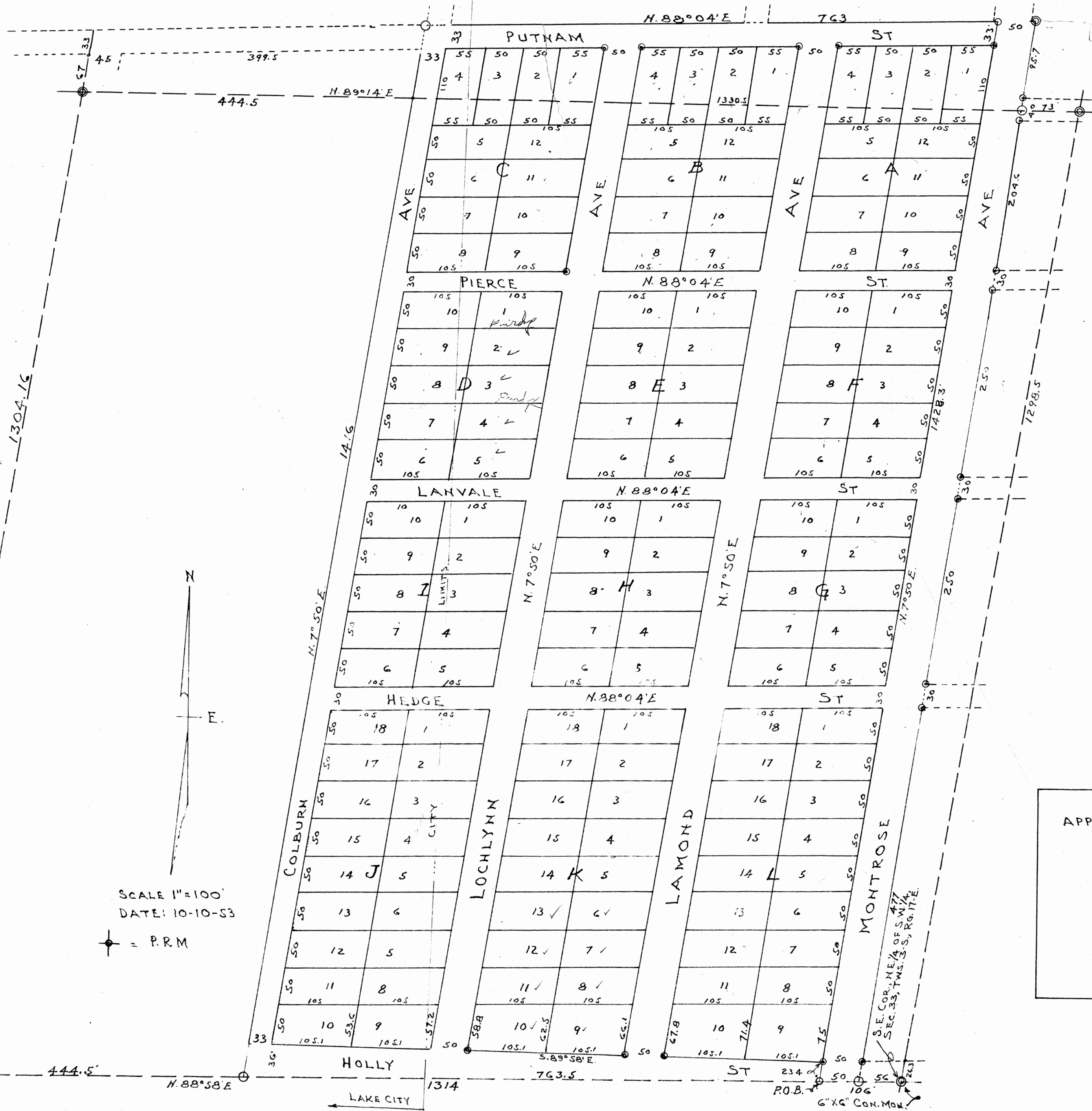


# MELROSE PARK

## DESCRIPTION

COMMENCE AT THE S.E. CORNER OF THE N.E. 1/4 OF THE S.W. 1/4 OF SAID SECTION 33 AND S. 88° 58' W. 106 FEET FOR A POINT OF BEGINNING AND RUN THENCE S. 88° 58' W. 763.5 FEET, THENCE N. 7° 50' E. 1416 FEET, THENCE N. 88° 04' E. 763 FEET, THENCE S. 7° 50' W. 1428.3 FEET TO POINT OF BEGINNING.
