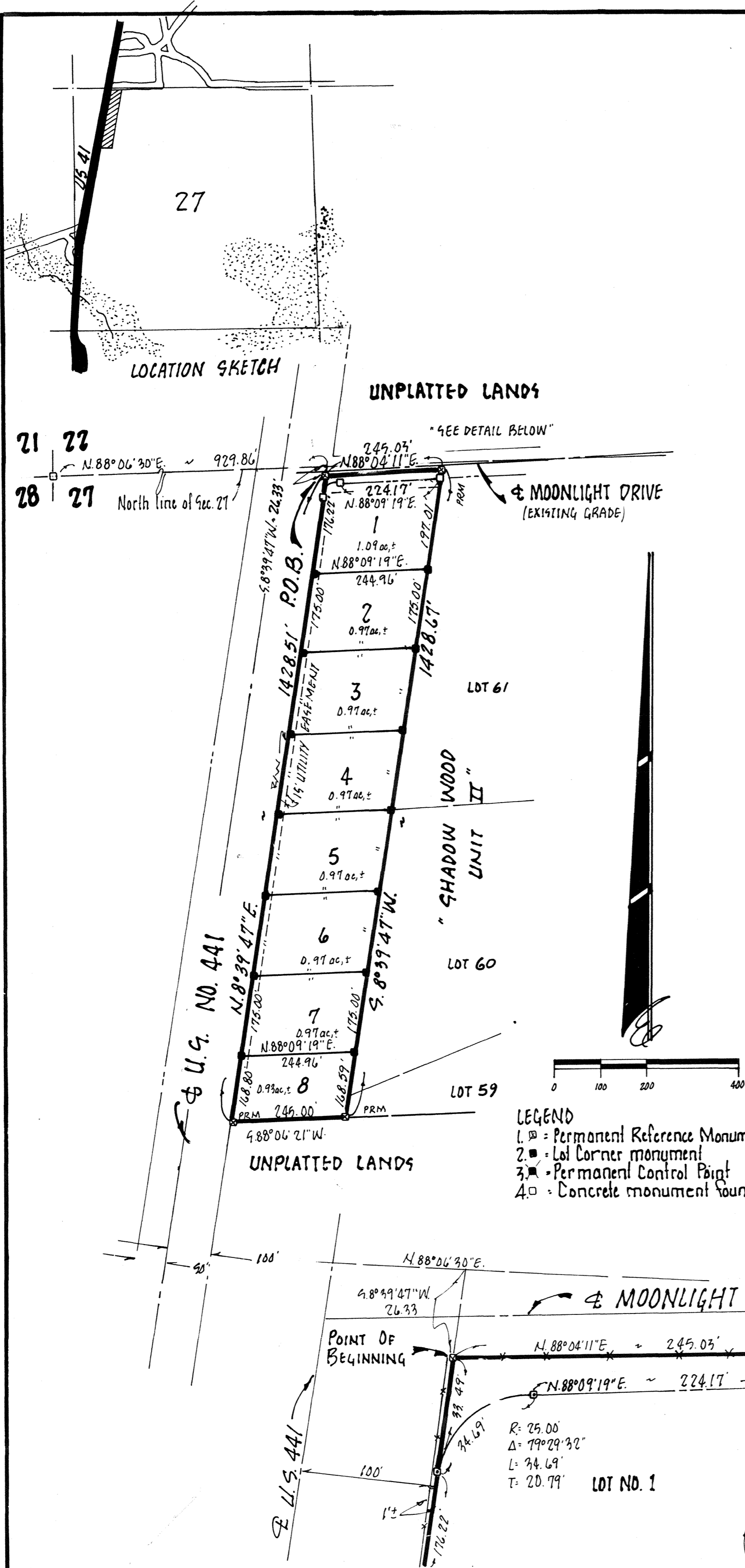


SHADOW WOOD UNIT I

COLUMBIA COUNTY, FLORIDA



DESCRIPTION

COMMENCE at the Northwest Corner of Section 27, Township 6 South, Range 17 East, Columbia County, Florida and run N. 88° 06' 30" E, along the North line of said Section 27, a distance of 929.86 feet to the Easterly right of way line of State Road No. 41; thence S. 8° 39' 47" W, along said Easterly right of way line 26.33 feet to the Southerly Maintained right of way line of a County Grade and the POINT OF BEGINNING; thence N. 88° 04' 11" E, along said Southerly Maintained right of way line 245.03 feet; thence S. 8° 39' 47" W, 1428.67 feet; thence N. 88° 06' 21" W, 245.00 feet to said Easterly right of way line; thence N. 8° 39' 47" E, along said Easterly right of way line, a distance of 1428.51 feet to the POINT OF BEGINNING. Containing 7.90 Acres, more or less.
