

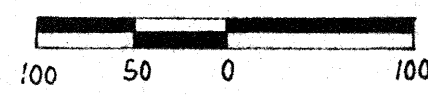

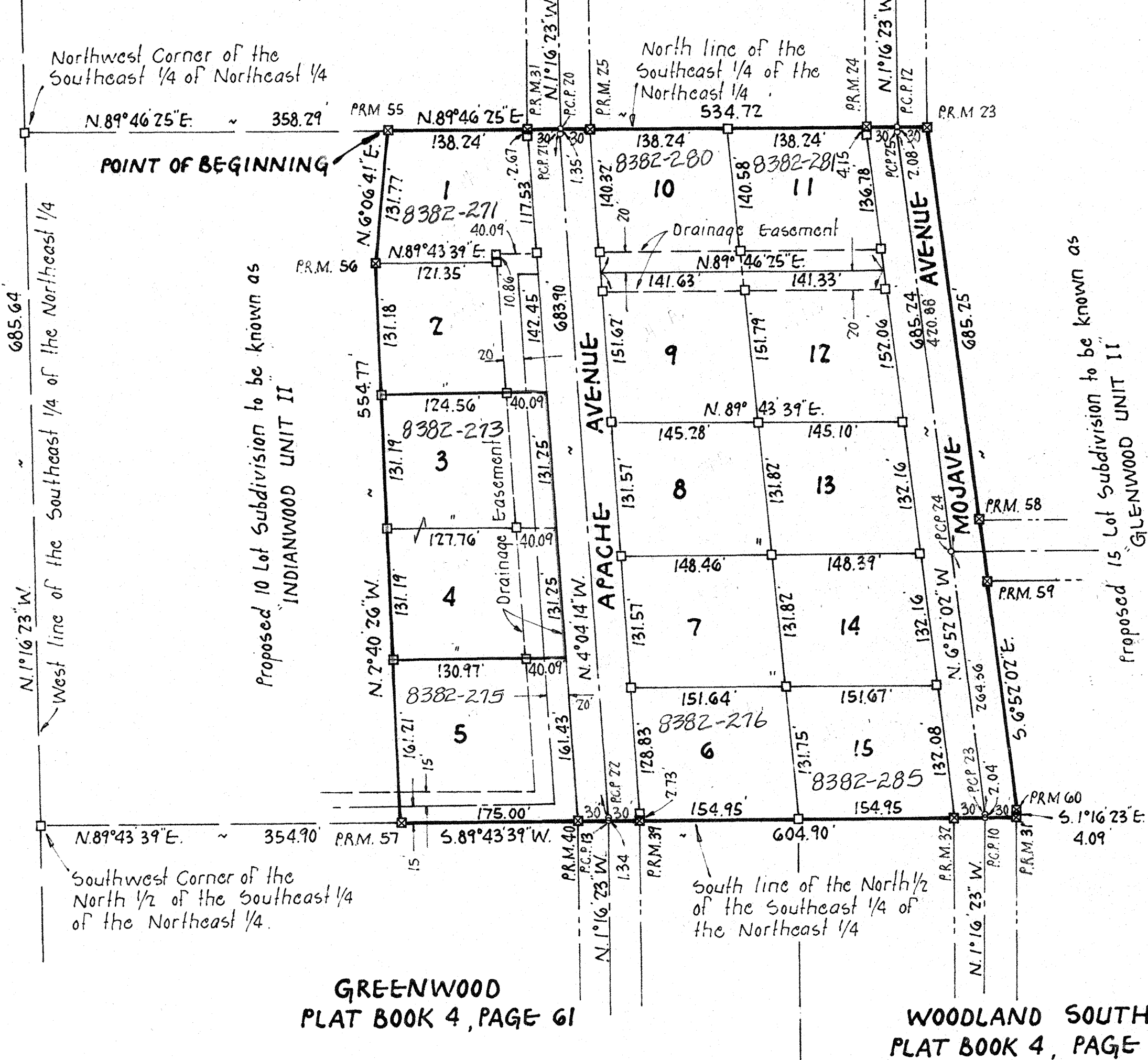

### DESCRIPTION:

COMMENCE at the Northwest Corner of the Southeast 1/4 of the Northeast 1/4, Section 16, Township 4 South, Range 17 East, Columbia County, Florida and run N. 89° 46' 25" E. along the North line of said Southeast 1/4 of Northeast 1/4 a distance of 358.29 Feet to the POINT OF BEGINNING; thence continue N. 89° 46' 25" E. along said North line 534.72 Feet; thence S. 6° 52' 02" E. 685.25 Feet; thence S. 1° 16' 23" E. 4.09 Feet to the South line of the North 1/2 of said Southeast 1/4 of Northeast 1/4; thence S. 89° 43' 39" W. along said South line 604.90 Feet; thence N. 7° 40' 26" W. 554.77 Feet; thence N. 6° 06' 41" E. 131.77 Feet to the POINT OF BEGINNING. Containing 9.09 Acres, more or less.

### LEGEND:

1.  $\blacksquare$  = 4"x4" Concrete Monument (Permanent Reference Monument) with Brass cap in top stamped L.L. Lee and Associates, Inc. with surveyors registration number, date, and monument number.
2.  $\square$  = 4"x4" Concrete Monument with Brass cap in top stamped L.L. Lee and Associates, Inc. with surveyors registration number and date set.
3.  $\circ$  = Permanent Control Point (PCP) - 1/2" Iron rod with cap stamped with PCP number and surveyors registration.
4. Bearings projected from State Road No. S-133.
